

1 RESOLUTION NO. 11 - 2011

RESOLUTION CONFIRMING THE APPOINTMENT OF THEODORE WILKINSON, P.E. OF FEDERICI & AKIN ENGINEERS, P.A. TO THE POSITION OF TOWNSHIP WATER AND SEWER ENGINEER IN GREENWICH TOWNSHIP, GLOUCESTER COUNTY, NEW JERSEY

WHEREAS, there exists a need for specific engineering services for multiple and diverse water and sewer projects in the Township of Greenwich, County of Gloucester, and State of New Jersey; and

WHEREAS, the Greenwich Township Council has solicited a Request for Proposal (hereinafter “RFP”) pursuant to a “fair and open process” in order to choose a qualified person or entity to provide professional services as Township Water and Sewer Engineer for Greenwich Township; and

WHEREAS, the Greenwich Township Administrator reviewed the responses to a public notice soliciting RFPs for the position of Greenwich Township Water and Sewer Engineer, the Township Administrator has recommended the appointment of Theodore Wilkinson, PE of Federici & Akin Engineers, P.A. to perform services upon designated water sewer projects for the Township during the calendar year 2011 per attached agreement;

WHEREAS, after review of the RFPs and the recommendations of the Township Administrator the Greenwich Township Mayor has determined to appoint Theodore Wilkinson, PE of Federici & Akin Engineers, P.A. as Greenwich Township Water and Sewer Engineer for the 2011 calendar year and the Greenwich Township Council has confirmed such appointment; and

NOW, THEREFORE, be it resolved by the Township Council, Township of Greenwich, County of Gloucester, State of New Jersey as follows:

1. The Mayor hereby appoints and the Township Council confirmed the appointment of Theodore Wilkinson, PE of Federici & Akin Engineers, P.A. as Township Water and Sewer Engineer to furnish engineering services on behalf of the said Township, and the Mayor and the Municipal Clerk are hereby authorized and directed to enter into an agreement with such engineer, to furnish the services

required by the Township of Greenwich, for the position of the which he is appointed for the period of January 1, 2011 to December 31, 2011.

2. This contract is awarded as a competitive contract for a “professional service” for which RFPs were solicited in accordance with a “fair and open process” established by law and under the provisions of the Local Public Contracts Law because the persons employed herein are authorized by law to practice a recognized profession in the State of New Jersey, and the services to be performed are not capable of competitive contracting in accordance with the above cited statutes.

3. A Notice of Adoption of this Resolution shall be published in the Gloucester County Times, Woodbury, New Jersey, as required by law.
