**RESOLUTION ADOPTING A SCHEDULE OF REGULAR MEETING DATES
FOR THE GREENWICH TOWNSHIP COUNCIL, COUNTY OF GLOUCESTER,
STATE OF NEW JERSEY FOR THE YEAR 2011**

WHEREAS, the Township of Greenwich is required, pursuant to the provision of the Open Public Meetings Act, to provide notice of all meetings as specified in the Act;

NOW, THEREFORE, BE IT RESOLVED by the Greenwich Township Council as follows:

1. The Greenwich Township Council hereby designates the following dates for its reorganization, work sessions and regular meetings:

All regular meetings shall commence at 7:00 p.m. The regular meetings will be held in the Greenwich Township Library, 411 Swedesboro Road, Gibbstown, New Jersey;

2. Notice of the regular and special meetings of the Greenwich Township Council shall be posted forty-eight (48) hours in advance on the bulletin board in the Municipal Building;

3. The following two (2) newspapers circulating in the Township of Greenwich are: THE GLOUCESTER COUNTY TIMES and THE COURIER POST;

4. A copy of this resolution, together with advance notice of regular and special meetings of the Township council shall be mailed to the above named newspapers;

5. A copy of advance notice of regular and special meetings of the Township Council shall be filed with the Township Clerk of Greenwich Township;

6. Any person may request, in writing, that the governing body mail to him a copy of the schedule of regular meetings of the Township council and/or advance written notice of regular, special or re-scheduled meetings. Upon prepayment by such person of the applicable fee hereinafter set forth, such schedules or advance notices shall be mailed to such person. All requests made pursuant to this paragraph shall terminate at midnight, December 31 of the current year, subject to renewal thereafter upon the filing of a new written request to the governing body together with prepayment of the applicable fees. Notices requested by news media shall be mailed to one representative of such media free of charge.

Advance written notice of all regular, special or rescheduled meetings
during the calendar year\$2.00/mo.

7. All advance notices referred to in this resolution for the regular, special and re-scheduled meetings shall include the agenda to the extent known and those matters upon which formal action may be taken.

8. The council may hold a meeting without compliance with the notice requirements of this resolution if such meeting is required to deal with matters of such urgency and importance that delay for purpose of providing adequate notice would be likely to result in substantial harm to the public interest.
