

1RESOLUTION NO. 28 - 2011

RESOLUTION CONFIRMING THE APPOINTMENT OF LOUIS ROSNER, ESQUIRE AS SPECIAL EMPLOYMENT COUNSEL IN GREENWICH TOWNSHIP, GLOUCESTER COUNTY, NEW JERSEY

WHEREAS, there exists a need for certain legal services in the Township of Greenwich, County of Gloucester, State of New Jersey; and

WHEREAS, there are funds available for this purpose as reflected in the attached Certificate of Available Funds, see Schedule A; and

WHEREAS, the Greenwich Township Council has solicited a Request for Proposal (hereafter "RFP") pursuant to a "fair and open process" in order to choose a qualified person or entity to provide professional services as the Township Special Employment Counsel for Greenwich Township; and

WHEREAS, the Greenwich Township Administrator reviewed the responses to a public notice soliciting RFPs for the position of Greenwich Township Special Employment Counsel, the Township Administrator has recommended the appointment of Louis Rosner, Esquire to the position of Greenwich Township Special Employment Counsel; and

WHEREAS, after review of the RFPs and the recommendation of the Township Administrator the Greenwich Township Mayor has determined to appoint Louis Rosner, Esquire to the position of Greenwich Township Special Employment Counsel for the 2011 calendar year and the Greenwich Township Council have consented to this appointment.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council, Township of Greenwich, County of Gloucester, State of New Jersey as follows:

1. The Mayor hereby appoints and the Township Council confirms the appointment of Louis Rosner, Esquire to Greenwich Township Special Employment Counsel to furnish legal services on

behalf of the said Township, and the Mayor and the Municipal Clerk are hereby authorized and directed to enter into an agreement with Louis Rosner, Esquire, to furnish the particular services required by the Township of Greenwich, for the position of which he is appointed for the period of January 1, 2011 to December 31, 2011.

2. This contract is awarded as a competitive contract for a “professional service” for which RFPs were solicited in accordance with a “fair and open process” established by law and under the provisions of the Local Public Contracts Law because the person employed herein is authorized by law to practice a recognized profession in the State of New Jersey, and the services to be performed are capable of competitive contracting in accordance with the above cited statutes.

3. A Notice of Adoption of this Resolution shall be published in the Gloucester County Times, Woodbury, New Jersey, as required by law.
